- 1. Carefully clean and dry all surfaces to be bonded.
- If packaged in BIPAX, remove clamp and thoroughly mix the LOCTITE ABLESTIK 862-2 epoxy adhesive system components in the handy BIPAX mixing-dispenser package until color is uniform throughout.
- 3. If pre-mixed and frozen, thaw adhesive to room temperature. A 25°C water bath is recommended.
- Apply this completely mixed adhesive to the prepared surfaces, and gently press these surfaces together. Contact pressure is adequate for strong, reliable bonds; however, maintain contact until adhesive is completely cured.
- 5. Cure at recommended cure schedules.
