

THAWING:

- 1. Allow container to reach room temperature before use.
- After removing from the freezer, set the syringes to stand vertically while thawing.
- DO NOT open the container before contents reach 25°C temperature. Any moisture that collects on the thawed container should be removed prior to opening the container.
- DO NOT re-freeze. Once thawed to 25°C, the adhesive should not be re-frozen.



DIRECTIONS FOR USE

- 1. Mix component thoroughly before use.
- 2. Blend equal weights of Part A and B (1:1 ratio) thoroughly.
- Scrape the sidewall and bottom of container repeatedly during mixing.
- To ensure the absence of unmixed adhesive, transfer contents to a secondary, empty container and mix for an additional minute.
- 5. Apply adhesive as required.
- 6. Cure at one of the recommended cure schedules.
