THAWING:

- 1. Allow container to reach room temperature before use.
- DO NOT open the container before contents reach 25°C temperature. Any moisture that collects on the thawed container should be removed prior to opening the container.
- DO NOT re-freeze. Once thawed, the adhesive should not be re-frozen.

DIRECTIONS FOR USE

- 1. Clean all surfaces to be bonded.
- Precut adhesive to the same size as, or slightly smaller than, the substrate.
- 3. Place in position in the package (header).
- 4. Place in a preheated oven for 5 minutes to allow removal of absorbed moisture and traces of retained solvent.
- 5. If no clamping pressure is used during the curing, mount the substrate either while hot or after cooling to ambient.
- 6. Place on a heating block at 150°C.
- 7. Press or scrub the substrate until an acceptable fillet is obtained.
- 8. Place in pre-heated oven and cure at the recommended cure schedule.

- LOCTITE ABLESTIK 564AK adhesive is available in sheet stock or die cut preforms.
- This material may be purchased with Method 5011 certification at an additional charge.
